Notice to Exhibitors

Competitors, through submission of entry, acknowledge that they are knowledgeable of the RallyUP rules including but not limited to the following rules regarding entry:

- ✓ All exhibitors are expected to treat the judges, trial hosts, your canine partner and all other exhibitors with respect.
- ✓ All judges and trial hosts are expected to show respect to all exhibitors.
- ✓ This trial is open to all dogs registered with GAD/RallyUP.
- ✓ Owners with physical challenges are encouraged to compete. All reasonable accommodations will be made as needed.
- ✓ Safety shall always be of foremost consideration in actions and conduct by handlers at all times. Handlers, through entry at this event, accept full responsibility for themselves and the actions of their dogs. In addition, we may refuse any entry for any reason.
- ✓ THERE SHALL BE NO REFUND for entries in the event a dog and/or handler are dismissed from competition, regardless of reason for such dismissal.
- ✓ Refunds will be made for females in season upon written request accompanied by a statement from the exhibitor's veterinarian.
- ✓ Returned checks do not constitute a valid entry. There will be a \$25.00 service charge for returned checks
- ✓ All competitors through entry at this event waive any and all rights relative to video broadcast of this event. Competitors shall have the right to videotape portions of this event for their personal use only. No portion of this event may be videotaped for commercial or other purposes.
- ✓ Dogs must be on leash while on show grounds unless being shown.
- ✓ Please pick up after your dog and yourself.

Entry fees:

Pre-entry fees for individual classes are \$15 first entry, \$10 each additional entry same dog all day. \$15 entry fee applies for first entry each day same dog. **Partner Relay** class is \$10 per dog.

Pre entry deadline: January 30, 2012.

Day of Show entries are \$20 first, \$15 each additional same dog all day provided pre-entry limit has not been reached. **Partner Relay** class is \$10 per dog.
